GUIDELINES FOR DR. NEMICHAND JAIN MEMORIAL AWARD

- Two awards carry a cash component of Rs.1 Lac for each; One for the award to journals in Hindi and the other for English.
- The publication/ journal should have been registered for a period of at least five years and should have continued publication without interruption during this period for eligibility of the award.
- The periodicity of publication should be prescribed and should be followed strictly. We should be free to call for any specified issue for inspection.
- The Editor and the Board of Management should be identifiable.
- Details regarding ownership etc. should appear at the end of this financial year as prescribed by the Registrar of publication.
- The quality of presentation of the Journal must be elegant.
- The publication including the cover page should at least consist of 50 pages.
- While fiction need not be avoided, the same should not be in bad taste or incorporate pictures / photographs of objectionable date
- Publication should preferably be a priced one. The price or cater to salacious taste. should be stated on each issue.
- The contributions incorporated should not be mere translation of material published elsewhere though an occasional inclusion of such an article would not be objected to.
- Generally the publication should include articles on vegetarianism, non-violence, teachings of Sadhus and spiritual standards to be followed by the younger generation

- The editor should not have been punished on charges relating to moral turpitude or any other criminal offence. No prosecution should have been launched against the publication under any provisions of IPC.
- Receipt of awards by the journal for excellence in contents and get up etc. would carry weight with the members of Jury.
- The Jury would be free to ask for details regarding number of copies brought out for each issue.
- The title of the publication should be non controversial.
- The journal is free to include advertisements in good taste. Advertisements should not dominate the publication i.e. exceeding 50% of the contents.
- Please enclose a copy of Audit Bureau of Circulations Certificate, if available.
- Please enclose last five years journals, one from each year (5 Nos.) with the application.
- Please furnish the website link, if the journals are available online.
- Additional sheets can be used wherever necessary.
- All disputes relating to the awards are subject to the jurisdiction of the courts at Chennai only.
- The Jury reserves the right, not to make any award in the event none of the nominations come up to the standards adopted by them.
- The Jury may also consider published and unpublished books for the Award.
